I hope this finds you well! As many have read in the latest issue of the Communicator, we are getting ready to kick off our 2017 FitLiving Toolkit program! Those of you who participated in our Fitbit program last year will be pleased with the updates to this year's program ☺ **Just a head's up: the following information is just for your information to decide if your district would like to participate or not. I will be sending out the flyer with more detailed information for your employees as soon as I have confirmation from you and the name of the internal contact you would like listed on the flyer.**

Here is the rundown of RTS' 2017 FitLiving Registration Process:

We have streamlined the registration process down to three simple steps. And the best part?? The entire process is online! No more mailing or faxing those forms!

Beginning January 2, 2017 through February 24, 2017, employees will be able to register for their Fitbit by completing the following process: (we will provide links to all the steps in the flyer, as well as at our website)

1) Create a ClearCost account, OR, if an account was previously created, participants will be asked to log in to their account to review their past care.

2) Submit the registration form at our website

(note: individuals will be asked to use their mouse or track pad to sign)

3) We now have our own online Fitbit Store! **After we verify eligibility**, we will send those who complete the registration process a coupon code to shop online at Resource Training and Solutions' Fitbit store, compare different devices, and have their Fitbit shipped directly to them!

*****Please note: The verification process to receive a coupon code may take up to 3 weeks after the registration form is submitted. Codes are not immediately generated upon submission of the registration form.**

The awesomeness continues... ☺

This year we are offering **FIVE** different options of devices in our store, as well as numerous band options, AND the Fitbit Aria scale! Three of the wearable devices are offered at no cost (Fitbit One, Alta, Charge 2), and the two high end devices (the Blaze and the Surge) are available at a significantly reduced rate.
